ENTRY REQUIREMENTS

- ➔ A Bachelor's Degree (Level 6, Malaysia Qualifications Framework (MQF) in the Law Enforcement field or related fields with a minimum Cumulative Grade Point Average (CGPA) of 2.75 or equivalent. Applicants with a degree from non-relevant fields will be required to pass the prerequisite requirements set by the university.
- ➔ A Bachelor's Degree (Level 6, MQF) in the Law Enforcement field or related fields or equivalent with a minimum CGPA of 2.50 and not meeting CGPA of 2.75, can be accepted subject to rigorous internal assessment.
- ➔ A Bachelor's Degree (Level 6, MQF) in the Law Enforcement field or related fields or equivalent with minimum of five years working experience in the relevant field and rigorous internal assessment.
- ➔ Candidates without a related qualification in the field/s or working experience in the relevant fields must undergo appropriate prerequisite courses determined by the university and meet the minimum CGPA based on I to iii above.
- ➔ Any equivalent qualification recognised by the University Senate.
